### 1. Call to order

Executive Director Corinne Sedran and Board President Joshua Wasson dialed in to the conference call from the board office. Committee members had been notified of the meeting date and time in an email on September 11, 2014. Wasson and Sedran kept the teleconference line open for five minutes and were not joined by any other board members.

Wasson called the meeting to order at 5:35 p.m. He stated board member Daniel Harris was supposed to be present for the subcommittee meeting as discussed at the August 13<sup>th</sup> regular board meeting. There were no guests in attendance at the meeting.

Wasson stated he went through the board's archived exam materials and located an exam titled, "Basic Contact Lens" which he believes can be used to prepare the exam for September 27<sup>th</sup>. The upgrade exam will be administered during the dispensing portion of the regular exam.

Wasson closed the meeting on his own motion pursuant to NRS 241.030(1)(b): a public body may hold a closed meeting to prepare, revise, administer or grade examinations that are conducted by or on behalf of the public body. Wasson and Sedran reviewed the requirements of NRS 637.160 and ensured the exam would comply. They also scheduled a date to prepare the examinations.
