NOTICE OF WORKSHOP FOR THE ADOPTION OF REGULATIONS OF THE NEVADA STATE BOARD OF DISPENSING OPTICIANS

NOTICE IS HEREBY GIVEN that the Nevada State Board of Dispensing Opticians will hold a public workshop at **1 p.m. on Tuesday, October 20, 2015 at the Nevada State Contractors Board Offices: 9670 Gateway Drive, Suite 100, Reno, Nevada and 2310 Corporate Circle, Suite 200, Henderson, Nevada.** The purpose of the workshop is to receive comments from all interested persons regarding the potential adoption of regulations pertaining to chapter 637 of the Nevada Administrative Code.

The purpose of the proposed regulation includes: (1) further describing when Board members are entitled to their salary; (2) various changes to the regulations regarding the supervision of and qualifications for apprentices; (3) eliminating certain specific requirements for the testing of candidates for licensure; (4) various changes to continuing education requirements; and (5) repealing the Board's tracking of an apprentices orderly progress of his or her education.

Persons wishing to comment upon the proposed action of the Nevada State Board of Dispensing Opticians may appear at the scheduled public workshop or may address their comments, data, views, or arguments, in written form, to: Nevada State Board of Dispensing Opticians, 4790 Caughlin Parkway #241, Reno, Nevada 89519-0907. Written submissions must be received by the Nevada State Board of Dispensing Opticians on or before October 13, 2015. If no persons directly affected by the proposed action appear to request time to make oral presentations, the Nevada State Board of Dispensing Opticians may proceed immediately to act upon any written submissions.
