Notice of Workshop for the Adoption of Regulation R101-22

NOTICE IS HEREBY GIVEN that the Nevada State Board of Dispensing Opticians will hold a public workshop at 5:00 p.m. on Thursday, November 10, 2022. The purpose of the workshop is to receive comments from all interested persons regarding the potential adoption of Proposed Regulation R101-22, which will amend Chapter 637 of the Nevada Administrative Code. The workshop will be held via teleconference, and all may attend by dialing: **(617) 829-6755**.

The purposes of the proposed regulation include, without limitation: (1) interpreting various terms included in the definition of ophthalmic dispensing in Chapter 637 of the Nevada Revised Statutes; (2) revising the definition of “dispensing optician” to include persons who hold a limited license as a dispensing optician; (3) clarifying that “managing a business engaged in ophthalmic dispensing” refers to acting as an ophthalmic manager, as described in the regulation, and setting forth the duties of such a manager; (4) clarifying a provision related to what constitutes a quorum of the Board; (5) clarifying requirements for applications for a special license; (6) clarifying the scope of practice of laboratory personnel; (7) reorganizing and clarifying provisions related to applying for a license as a dispensing optician; (8) revising provisions related to administering exams; (9) revising provisions related to continuing education requirements; (10) clarifying the terms of license inactivation and reactivation; (11) reorganizing fees into a single section and increasing certain fees; (12) reorganizing provisions related to “unethical or unprofessional conduct”; (13) revising provisions related to the required equipment for ophthalmic dispensing; and (14) revising provisions related to apprentice licensure, including application requirements, supervision, and limits on license renewal.

SMALL BUSINESS IMPACT STATEMENT AS REQUIRED BY NRS 233B.0608
AND NRS 233B.0609

LCB File No. R101-22

(1) A description of the manner in which comment was solicited from affected small businesses, a summary of their responses, and an explanation of the manner in which other interested persons may obtain a copy of the summary.

The Board determined the proposed regulation would not impact small businesses through discussions at its regular meetings throughout 2021 and 2022. The Board members are employed by a range of employer types, from large corporations, to small, independent offices. None of the Board members expressed concern that the proposed regulation would create a financial burden on their employers. The Board did not receive any testimony from the public during these meetings indicating the proposed regulations would cause a negative impact on small businesses.

(2) The manner in which the analysis was conducted.

The Board analyzed the proposed language and used informed, reasonable judgment in determining that there will not be an impact on small businesses due to the nature of the regulatory changes.

(3) The estimated indirect and direct economic effect of the proposed regulation on the small businesses it is to regulate, including, without limitation, (1) both adverse and beneficial effects; and (2) both direct and indirect effects.

There would be no (1) adverse or beneficial economic effect on small businesses, or (2) direct or indirect economic effects on small businesses.

(4) A description of the methods that the agency considered to reduce the impact of the proposed regulation on small businesses and a statement regarding whether the agency actually used any of those methods.

The proposed regulation presents no reasonable, foreseeable or anticipated adverse impact to small businesses; therefore, no efforts were required to reduce the impact on small businesses.

(5) The estimated cost to the agency for enforcement of the proposed regulation.

The proposed regulation presents no significant foreseeable or anticipated costs for enforcement.

(6) If the proposed regulation provides a new fee or increases an existing fee, the total annual amount the agency expects to collect and the manner in which the money will be used.

The proposed regulation increases the annual fee for renewal of a Dispensing Optician License by \$50, and the fee for reactivation of a Dispensing Optician License or inactivation of a Limited Dispensing Optician License by \$50. The agency will collect approximately \$18,000 annually from the additional fees. These funds will be used to cover increased administrative costs due to creating and maintaining online applications, forms, and exams, as well as regular cost increases related to running the Board office.

(7) If the proposed regulation includes provisions which duplicate or are more stringent than federal, state or local standards regulating the same activity, an explanation of why such duplicative or more stringent provisions are necessary.

The proposed regulation does not overlap or duplicate any standards of other federal, state or local government entities.

(8) The reasons for the conclusion of the agency regarding the impact of a regulation on small businesses.

The purpose of the proposed regulation is to revise and codify procedures and standards for the training and practice of ophthalmic dispensing in the State, as well as streamline provisions related to the functions of the Board. There will therefore be no adverse impacts to small businesses.

**REVISED PROPOSED REGULATION OF THE
BOARD OF DISPENSING OPTICIANS**

AUTHORITY: §§ 1-8, 18-20 and 25, NRS 637.070; § 9, NRS 637.070 and 637.127; §§ 10 and 11, NRS 637.070 and 637.090; §§ 12, 13 and 24, NRS 637.070 and 637.100; §§ 14 and 15, NRS 637.070, 637.121 and 637.135; § 16, NRS 637.070, 637.121 and 637.140; § 17, NRS 637.070, 637.100, 637.110, 637.121, 637.123, 637.140 and 637.170; § 21, NRS 637.070, 637.100 and 637.110; § 22, NRS 637.070, 637.100 and 637.123; § 23, NRS 637.070, 637.100 and 637.125.

A REGULATION relating to dispensing opticians; interpreting certain terms relating to dispensing opticians; revising provisions relating to the renewal of a license of an apprentice dispensing optician; making various changes relating to the operation of the Board of Dispensing Opticians; revising provisions relating to the authorized scope of practice of certain laboratory personnel; revising the responsibilities of an ophthalmic manager; clarifying and reorganizing certain provisions relating to an application and examination for a license and limited license as a dispensing optician; revising certain continuing education requirements for licensees; increasing certain licensing fees; revising provisions relating to certain unethical or unprofessional conduct of licensees; setting forth certain requirements for cleaning equipment related to the practice of dispensing opticians; revising the application requirements for licensure as an apprentice dispensing optician; repealing and reorganizing certain provisions; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law defines the term “ophthalmic dispensing” to mean the design, verification and delivery to the intended wearer of lenses, frames and other specially fabricated optical devices upon prescription. The term includes, in relevant part: (1) the preparation and delivery of work orders to laboratory technicians engaged in grinding lenses and fabricating eyewear; and (2) the verification of the quality of finished ophthalmic products. (NRS 637.022) **Sections 2 and 3** of this regulation, respectively, interpret the terms “ophthalmic product,” “delivery to the intended wearer,” “design,” “preparation and delivery of work orders” and “verification.”

Section 5 of this regulation revises the definition of “dispensing optician” to mean: (1) a person who holds a license as a dispensing optician; or (2) a person who holds a limited license as a dispensing optician.

Section 6 of this regulation revises the definition of “manage a business engaged in ophthalmic dispensing” to clarify that it means acting as an ophthalmic manager, as described in NAC 637.144.

Section 7 of this regulation clarifies the severability provision contained in the chapter of the Nevada Administrative Code relating to dispensing opticians.

Section 8 of this regulation clarifies that a majority of the members of the Board of Dispensing Opticians constitutes a quorum.

Existing law requires the Board to issue a special license as a dispensing optician to certain candidates who have either: (1) an active license as a dispensing optician issued by the District of Columbia or any state or territory of the United States; or (2) not less than 5 years of experience as a dispensing optician. (NRS 637.127) Existing regulations interpret the requirement to have not less than 5 years of experience to include as a portion thereof the requirement of 100 hours of experience relating to the fitting and filling of prescriptions for contact lenses. (NAC 637.132)

Section 9 of this regulation interprets such requirement to instead mean that the applicant has at least 5 consecutive years of experience as a dispensing optician and that such experience was obtained not more than 2 years before the date of the application for the special license. **Section 9** further interprets the requirement to have an active license as a dispensing optician issued by the District of Columbia or any state or territory of the United States to mean that the Board finds that the requirements for such an active license meet or exceed the requirements for a license as a dispensing optician in this State.

Existing regulations set forth the scope of practice of laboratory personnel. (NAC 637.140) **Section 10** of this regulation revises such scope of practice.

Existing regulations set forth the duties of an ophthalmic manager. (NAC 637.144) **Section 11** of this regulation revises such duties.

Existing regulations set forth the requirements for an application for the examination required to obtain a license as a dispensing optician. (NAC 637.150) **Section 12** of this regulation clarifies that the application is for a license as a dispensing optician and reorganizes the provisions. **Section 12** further provides that the Board will grant an applicant credit for certain required training and experience that was completed not more than 5 years before the application date and under the direct supervision of a dispensing optician who meets certain qualifications.

Existing regulations set forth requirements relating to the scope, content and administration of the examination that is required for a license or limited license as a dispensing optician, including that the Board may employ others to assist in administering the examination. (NAC 637.160) **Section 13** of this regulation provides that the Board may also use certain examinations that are administered by an independent organization if the examinations satisfy the requirements for the examinations that are administered by the Board.

Existing regulations require that a dispensing optician submit to the Board certain information related to each course of continuing education completed by the licensee. (NAC 637.190) **Section 14** of this regulation requires that the dispensing optician also indicate whether each course of continuing education has been approved as instruction related to the practice and theory of fitting contact lenses.

Existing regulations: (1) provide that a licensee is not entitled to receive credit for a course of continuing education unless the course is approved by the Board; and (2) authorize a licensee to seek approval of a course before attending the course to receive credit towards his or her hours of continuing education. (NAC 637.200) **Section 15** of this regulation provides instead that any such request for approval must be submitted to the Board at least 90 days before the date on

which the licensee submits the required statement affirming that the dispensing optician completed the required hours of continuing education that is submitted to the Board at the time of license renewal.

Existing law and regulations require a dispensing optician to complete a minimum of 14 hours of continuing education, 7 hours of which must be related to the practice and theory of fitting contact lenses. (NRS 637.135; NAC 637.200) Existing regulations authorize, under certain circumstances, a dispensing optician to receive credit for not more than 4 hours of continuing education each year for certain community service time. (NAC 637.200) **Section 15** provides that community service time does not count towards the hours of instruction related to the practice and theory of fitting contact lenses unless the dispensing optician directly fitted and dispensed contact lenses during the community service time.

Existing regulations set forth the requirements for the holder of a license as a dispensing optician or a limited license as a dispensing optician to transfer such license to an inactive list under certain circumstances. (NAC 637.215) **Section 16** of this regulation provides that if a dispensing optician reactivates the license or limited license, as applicable, the dispensing optician may again at a later time transfer the license or limited license to the inactive list.

Existing regulations set forth fees for the application, renewal, reinstatement, transfer and reactivation of a license as a dispensing optician, limited license as a dispensing optician and license as an apprentice dispensing optician. (NAC 637.150, 637.220, 637.260, 637.265) **Section 18** of this regulation: (1) reorganizes such fees into one section of the Nevada Administrative Code; and (2) increases the fees for the renewal of a license as a dispensing optician, the transfer of a limited license as a dispensing optician to an inactive list and reactivation of a license as a dispensing optician. **Sections 12, 22, 23 and 26** of this regulation make conforming changes related to the reorganization of the fees into one section.

Section 19 of this regulation requires each licensee to file with the Board his or her electronic mail address, in addition to the existing requirements to file his or her home or mailing address and business address. (NAC 637.230)

Existing law authorizes the Board to take disciplinary action against an applicant or holder of a license for certain conduct, including that the applicant or licensee is guilty of unethical or unprofessional conduct. (NRS 637.150) Existing regulations: (1) interpret the phrase “unethical or unprofessional conduct” to include engaging in the sexual harassment of an employee or consumer; and (2) define “sexual harassment” to mean unwelcome sexual advances, requests for sexual favors or other speech or physical conduct of a sexual nature that has the purpose or effect of unreasonably interfering with an employee’s work performance or creating an environment which is intimidating, hostile or offensive to an employee or consumer. (NAC 637.235) **Section 20** of this regulation provides that the term “sexual harassment” includes, without limitation, such behavior.

Existing regulations require a dispensing optician to have certain optical equipment at the place of dispensing and prohibits a dispensing optician from fitting contact lenses unless the dispensing optician has access to certain equipment for fitting contact lenses. (NAC 637.241, 637.245) **Section 21** of this regulation: (1) requires that a dispensing optician have a manual or digital device used for taking optical measurements rather than a pupilometer; and (2) reorganizes the requirements for optical equipment into one section of the Nevada Administrative Code. **Section 26** of this regulation makes a conforming change to repeal the section of the Nevada Administrative Code that is no longer necessary. (NAC 637.245)

Existing regulations set forth the requirements to qualify for licensure as an apprentice dispensing optician, including the requirement to furnish proof that the applicant is of good moral character. (NAC 637.260) **Section 22** of this regulation eliminates this requirement. **Section 22** also requires that an applicant submit an affidavit attesting to the truthfulness of the statements set forth in the application.

Existing regulations require an apprentice dispensing optician to have on file with the Board a supervisor of record who is licensed in this State. (NAC 637.280) **Section 24** of this regulation requires that each apprentice dispensing optician also submit to the Board a statement from the supervisor of record attesting that the supervisor will train and supervise the apprentice dispensing optician in accordance with the provisions of the Nevada Revised Statutes and Nevada Administrative Code.

Existing regulations: (1) require an apprentice dispensing optician to submit to the Board evidence of enrollment in an educational program on the theory of ophthalmic dispensing approved by the Board or adequate prior ophthalmic experience; and (2) set forth certain requirements for training and experience. (NAC 637.285, 637.290) **Sections 4 and 25** of this regulation reorganize these provisions and **section 26** makes a conforming change to repeal the section of the Nevada Administrative Code that is no longer necessary. (NAC 637.290)

Section 26 also repeals: (1) certain definitions; (2) certain requirements related to training and experience related to the fitting and filling of prescriptions for contact lenses; (3) authority for an applicant to be issued a duplicate license; and (4) a provision that the Board will not approve more than 10 days of experience gained by an apprentice dispensing optician with a new employer before an amended application is received by the Board. (NAC 637.130, 637.148, 637.225, 637.300)

Section 1. Chapter 637 of NAC is hereby amended by adding thereto the provisions set forth as sections 2, 3 and 4 of this regulation.

Sec. 2. *As used in this chapter and NRS 637.022, the Board will interpret the term “ophthalmic product” to mean any material used for the correction or relief of or remedy for any abnormal condition or inefficiency of the eye or visual process. The term includes, without limitation, lenses, frames and other specially fabricated optical devices, including, without limitation:*

- 1. Ophthalmic lenses for sunglasses, dive masks, sports goggles and occupational goggles;*
- 2. Ophthalmic prescription lenses;*
- 3. Ophthalmic devices that have dioptric power and are attached to eyeglasses; and*

4. All prescription and nonprescription contact lenses, including, without limitation, prepackaged contact lenses, individual contact lenses, cosmetic contact lenses and theatrical contact lenses.

Sec. 3. *As used in NRS 637.022, the Board will interpret the term:*

1. “Delivery to the intended wearer” to mean that a dispensing optician has verified a finished ophthalmic product and has provided written authorization to have the ophthalmic product delivered to the intended wearer. The term does not include the physical delivery to the intended wearer by in-person delivery, mail or any other method for which a license is not required pursuant to chapter 637 of NRS.

2. “Design” to mean:

(a) The making of recommendations to the intended wearer of an ophthalmic product regarding the design features of the ophthalmic product, including, without limitation, lens material; and

(b) The preparation of a work order that will be used for the fabrication of the ophthalmic product that reflects the design features of the ophthalmic product chosen by the intended wearer.

3. “Preparation and delivery of work orders” to mean the creation and transmission of work orders for fabricating ophthalmic products through the process of entering prescription information or other fabricating instructions onto a paper or electronic form or into an electronic ordering system.

4. “Verification” to mean a physical and final inspection of a finished ophthalmic product by a dispensing optician before it is delivered to the intended wearer.

Sec. 4. 1. Except as otherwise provided in subsection 2, an apprentice dispensing optician who receives his or her initial license:

(a) Before November 1 of any year, may renew his or her license as an apprentice dispensing optician not more than four times.

(b) On or after November 1 of any year, may renew his or her license as an apprentice dispensing optician not more than three times.

2. An apprentice dispensing optician may request one additional renewal of his or her license pursuant to subsection 3 of NRS 637.123 by submitting the request to the Board on a form provided by the Board. Any such request must be submitted not later than 90 days before the end of the apprentice dispensing optician's final authorized renewal pursuant to subsection 1.

3. The Board will grant a request for an additional renewal pursuant to subsection 2 for good cause if the Board determines that:

(a) The apprentice dispensing optician was unable to complete the education and training requirements set forth in NRS 637.100 due to unforeseen or emergency circumstances, as determined by the Board, or due to other circumstances that were outside the control of the apprentice dispensing optician; and

(b) The apprentice dispensing optician can reasonably complete the remaining education and training requirements set forth in NRS 637.100 within the time provided by the additional renewal of his or her license.

4. An apprentice dispensing optician who fails to complete the education and training requirements set forth in NRS 637.100 during the time described in subsection 1 and, if applicable, subsection 2:

- (a) May not renew his or her license as an apprentice dispensing optician again; and*
- (b) May reapply for initial licensure as an apprentice dispensing optician not earlier than 1 year after the date on which his or her previous license as an apprentice dispensing optician expires.*

Sec. 5. NAC 637.006 is hereby amended to read as follows:

637.006 “Dispensing optician” means ~~the~~ :

- 1. A person ~~engaged in the practice of ophthalmic dispensing~~ who holds a license as a dispensing optician pursuant to NRS 637.120; or*
- 2. A person who holds a limited license as a dispensing optician pursuant to NRS 637.121.*

Sec. 6. NAC 637.009 is hereby amended to read as follows:

637.009 As used in this chapter and NRS 637.090, the Board will interpret the term “manage a business engaged in ophthalmic dispensing” to mean ~~having the responsibility for ophthalmic dispensing and having direct supervisory responsibility for employees who engage in ophthalmic dispensing, including employees who are not licensed pursuant to this chapter and chapter 637 of NRS, at a single place of business~~ *acting as an ophthalmic manager of an optical establishment as described in NAC 637.144.*

Sec. 7. NAC 637.020 is hereby amended to read as follows:

637.020 If any of the provisions of this chapter or any application thereof to any person, thing or circumstance is held invalid, ~~it is intended that~~ such invalidity *does* not affect the remaining provisions, or their application, that can be given effect without the invalid provision or application.

Sec. 8. NAC 637.110 is hereby amended to read as follows:

637.110 1. A majority ~~{vote}~~ of *the members of the Board constitutes a quorum. A* quorum of the Board is necessary to conduct *the* business ~~{}~~ *of the Board.*

2. *Robert's Rules of Order* govern the general conduct of meetings of the Board when not otherwise provided by these rules or by law. Persons who willfully disrupt meetings may be removed.

3. Special meetings may be called by the President of the Board on his or her own motion or by written consent of two or more other Board members.

Sec. 9. NAC 637.132 is hereby amended to read as follows:

637.132 With respect to an applicant for a special license as a dispensing optician pursuant to NRS 637.127, the Board will interpret:

1. The requirement ~~{of passing}~~ *to pass* an examination administered by the Board set forth in paragraph ~~{(i)}~~ *(h)* of subsection 1 of NRS 637.127 to mean that the applicant must pass the Board's examination for a license as a dispensing optician set forth in NAC 637.160.

2. *The requirement to have an active license as a dispensing optician set forth in subparagraph (1) of paragraph (i) of subsection 1 of NRS 637.127 to mean that the applicant has an active license as a dispensing optician that is issued by the District of Columbia or any state or territory of the United States and the Board finds that the requirements for such active license meet or exceed the requirements for a license as a dispensing optician set forth in this chapter and chapter 637 of NRS.*

3. The requirement ~~{of}~~ *to have not less than* 5 years of experience as a dispensing optician set forth in subparagraph (2) of paragraph ~~{(i)}~~ *(i)* of subsection 1 of NRS 637.127 to ~~{include as a portion thereof the requirement of 100 hours of experience relating to the fitting and filling of prescriptions for contact lenses set forth in subsection 1 of NAC 637.148.}~~ *mean that the*

applicant has at least 5 consecutive years of experience as a dispensing optician and that such 5 consecutive years of experience was obtained not more than 2 years before the date of application for the special license.

Sec. 10. NAC 637.140 is hereby amended to read as follows:

637.140 1. Except as otherwise provided by specific statute, a person who does not hold a license ~~as a dispensing optician, a limited license as a dispensing optician or a license as an apprentice dispensing optician~~ *issued pursuant to this chapter and chapter 637 of NRS* shall not provide any ophthalmic products directly to the public.

2. Laboratory personnel, including, without limitation, laboratory technicians, ~~shall be deemed not to be engaged in the practice of ophthalmic dispensing and are not required to be licensed pursuant to NRS 637.090 if the laboratory personnel:~~

~~—(a) Except as otherwise provided in subsection 3, do not perform any of the acts described in subsection 1 or 2 of NRS 637.022; and~~

~~—(b) Provide ophthalmic products only and directly to licensed dispensing opticians, licensed ophthalmologists and licensed optometrists.~~

~~—3. Without~~ *may, without* obtaining a license pursuant to this chapter and chapter 637 of NRS, ~~as a laboratory technician may~~ perform any act to the fullest extent for which a license is not required pursuant to this chapter and chapter 637 of NRS, including, without limitation, grinding lenses or fabricating eyewear, as described in paragraph (b) of subsection 2 of NRS 637.022.

637.144 1. ~~[An]~~ *Each optical establishment must have an* ophthalmic manager ~~[:] who:~~

(a) ~~[Must be]~~ *Is* a dispensing optician ; ~~[or a dispensing optician with a limited license;]~~

(b) Is responsible for supervising ~~[the]~~ *all aspects of* ophthalmic dispensing and the

An apprentice dispensing optician may be directly supervised by any licensed dispensing optician authorized to fit and fill prescriptions for contact lenses, licensed ophthalmologist or licensed optometrist in order to complete the 100 hours of training and experience in the fitting and filling of prescriptions for contact lenses required pursuant to subparagraph (2) of paragraph ~~(g)~~ (f) of subsection 1 of NRS 637.100.

~~7.1~~ 8. An apprentice dispensing optician, his or her supervisor of record and his or her substitute supervisor must be able to read, write, speak and understand the English language.

~~8.1~~ 9. The Board may require a supervisor of record to conduct a periodic review of an apprentice dispensing optician.

~~9.1~~ 10. As used in this section:

(a) “Directly supervise” means physically providing individual direction, control, inspection and evaluation of work based on the training, experience and education of the apprentice dispensing optician, and any other relevant factors.

(b) “Permanent change” means a change ~~in the supervisor of record of an apprentice dispensing optician~~ that lasts 7 days or longer.

(c) “Supervisor of record” means an ophthalmologist, an optometrist or a dispensing optician who directly supervises the apprentice dispensing optician.

Sec. 24. NAC 637.285 is hereby amended to read as follows:

637.285 1. An apprentice dispensing optician shall, within 6 months after the date of his or her initial licensure as an apprentice dispensing optician, submit evidence to the Board that he or she:

(a) Is enrolled in an educational program on the theory of ophthalmic dispensing *or in a course of study in a school which offers a degree of associate in applied science for studies in ophthalmic dispensing* approved by the Board ~~+~~, *as required pursuant to paragraph (e) of subsection 1 of NRS 637.100*; or

(b) Has ~~received adequate prior ophthalmic experience in lieu of the completion of an~~ *successfully completed the* educational program *or course of study that is* described in paragraph (a).

The Board will inactivate the license of an apprentice dispensing optician who fails to enroll in an educational program *or course of study* or fails to submit evidence of ~~experience~~ *successfully completing the educational program or course of study* to the Board and within the time required by subsection 1. The Board will notify the apprentice dispensing optician of such action. The decision to inactivate the license may be appealed by the apprentice dispensing

optician by submitting a written request to the Board within 30 days after the license becomes inactive.

4. An apprentice dispensing optician who ~~fails to complete his or her educational program in the time required by this section may not renew his or her license as an apprentice dispensing optician.~~

An apprentice dispensing optician who is not allowed to renew his or her license pursuant to subsection 6 may reapply for initial licensure as an apprentice dispensing optician not sooner than 1 year after the date on which his or her previous license as an apprentice dispensing optician expired.~~ *successfully completes a course of study in a school which offers a degree of associate of science in ophthalmic dispensing described in paragraph (a) of subsection 1 must receive at least 1,000 hours of training and experience at the fitting table and in preparing laboratory orders, verifying processed work from the laboratory and the performance of other duties related to ophthalmic dispensing.*

5. *The Board may, in its discretion, grant an apprentice dispensing optician credit for training and experience that was completed before the date on which an application for initial licensure as an apprentice dispensing optician was submitted.*

Sec. 25. NAC 637.130, 637.148, 637.225, 637.245, 637.265, 637.290 and 637.300 are hereby repealed.

TEXT OF REPEALED SECTIONS

637.130 Definitions. (NRS 637.070) As used in NAC 637.130 to 637.230, inclusive, unless the context otherwise requires:

1. “Dispensing optician” means a person who holds a license as a dispensing optician pursuant to NRS 637.120; and
2. “Dispensing optician with a limited license” means a person who holds a limited license as a dispensing optician pursuant to NRS 637.121.

637.148 Completion and proof of required hours of training and experience. (NRS 637.070, 637.100)

1. Except as otherwise provided in subsection 3, an applicant for a license as a dispensing optician must furnish proof on a form provided by the Board and signed by the supervisor of the applicant that he or she has completed the following hours of training and experience relating to the fitting and filling of prescriptions for contact lenses required pursuant to subparagraph (2) of paragraph (f) of subsection 1 of NRS 637.100:

- (a) Thirty hours of contact lens fitting;
- (b) Twenty hours of follow-up care relating to contact lens fitting;
- (c) Twenty hours of instrumentation;
- (d) Fifteen hours of insertion and removal of contact lenses;
- (e) Ten hours of inspection of contact lenses; and

(f) Five hours of filling prescriptions for contact lenses.

2. The completion of one or more courses of instruction in contact lens fitting or contact lens theory in a school which offers a degree of associate in applied science for studies in ophthalmic dispensing approved by the Board may count toward the completion of the hours of training and experience described in subsection 1.

3. The Board may request and accept other documentation proving that an applicant has completed the hours of training and experience described in subsection 1.

4. As used in subsection 1, “supervisor” means an ophthalmologist, an optometrist or a dispensing optician.

637.225 Issuance of duplicate license. (NRS 637.070, 637.120) The Board may, upon the receipt of a written application and the payment of a fee of \$25, issue a duplicate license to the applicant.

637.245 Equipment for fitting contact lenses. (NRS 637.070) A dispensing optician shall not fit contact lenses unless the dispensing optician has access to equipment for fitting contact lenses on the premises, including, without limitation:

1. A slit lamp;
2. A radioscope;
3. A keratometer;
4. A contact lens loop;
5. A thickness and diameter gauge;
6. A fluorescine scope; and
7. Trial lenses.

637.265 Fee for renewal or reinstatement of license; waiver of renewal fee for first renewal of license. (NRS 637.070, 637.123)

1. Unless waived, the fee for the annual renewal of a license as an apprentice dispensing optician is \$100. The Board will waive the annual renewal fee for the first renewal if the initial license was issued to the apprentice dispensing optician on or after November 1.

2. The annual delinquency fee for reinstatement of a license as an apprentice dispensing optician is \$100.

637.290 Training and experience; areas of instruction. (NRS 637.070, 637.100)

1. An apprentice dispensing optician who desires to obtain a license as a dispensing optician pursuant to NRS 637.120 must receive instruction and personal supervision in the skills required in an optical establishment and in related duties during the 3 years of training required pursuant to subparagraph (1) of paragraph (f) of subsection 1 of NRS 637.100. Such training must include at least 2,000 hours of training and experience at the fitting table and in preparing laboratory orders, verifying processed work from the laboratory and the performance of other duties related to ophthalmic dispensing.

2. An apprentice dispensing optician who desires to obtain a license as a dispensing optician pursuant to NRS 637.120 and who has successfully completed a course of study in a school which offers a degree of associate of science in ophthalmic dispensing must receive at least 1,000 hours of training and experience at the fitting table and in preparing laboratory orders, verifying processed work from the laboratory and the performance of other duties related to ophthalmic dispensing.

3. The completion of one or more courses taught in a school which offers a degree of associate in applied science for studies in ophthalmic dispensing may count toward the

completion of the hours of training and experience required pursuant to subsections 1 and 2 if the courses:

(a) Provide the apprentice dispensing optician with instruction equivalent to training and experience at the fitting table and in preparing laboratory orders, verifying processed work from the laboratory or the performance of other duties related to ophthalmic dispensing; and

(b) Are approved by the Board.

4. Upon approval by the Board, if an apprentice dispensing optician holds a limited license as a dispensing optician in good standing, the hours of training and experience that he or she received as a dispensing optician with a limited license may count towards the hours of training and experience required pursuant to subsections 1 and 2.

5. Areas of instruction for apprenticeship must include the following:

(a) Ocular anatomy, physiology and refractive anomalies of the eye;

(b) Processes of vision, especially the effect of light, lenses and prisms placed before the eye;

(c) Theoretical optics;

(d) Ophthalmic vocabulary;

(e) Ophthalmic prescription interpretation, eyeglass lens and contact lens identification, fitting and adjustment of eyeglasses, and use of instruments in the analysis of eyeglass lenses and contact lenses in a practical examination;

(f) All facets of ophthalmic dispensing procedures; and

(g) The provisions of this chapter and chapter 637 of NRS.

637.300 Change of employer. (NRS 637.070, 637.100) An amended application on a form prescribed by the Board must be submitted by an apprentice dispensing optician within 10 days after his or her employment changes. The Board will not approve more than 10 days of

experience gained by an apprentice dispensing optician with a new employer before the amended application is received by the Board.
